


heand Mastee's Communique



three basic yet fundamental principles. Consider as well, the indelible impression that this type of controversial behaviour may leave on potential candidates or new members, particularly as we address any prevailing issues regarding retention.

Controversy to a great extent, if not aimed towards a constructive and positive end, will in turn be the roadblock to any progress. We have all heard time and again that united we stand and divided we fall. Let us bear that in mind with our dealings with one



another. With an awareness that success of our organization flourishes when we can all uniformly recognize the goal, and with an understanding that collaboration and constructive communication will lead to a productive and successful end. Controversy and an unwillingness to receive another's point of view within the confines of the principles and values we profess to observe, will slow progress, effect the sentiments of the Brethren, and threaten any possibility of success. In fact, when any debate turns unproductive or is driven by discord, it becomes a barrier to progress

and growth.

Yet the dilemma is not necessarily with the conflict itself, or the diverse positions and views surrounding the issue, but more so with how we choose to deal with it. When a dispute arises, the best course of action is to resolve the issue in a state of harmony and peaceful negotiation. The events and trials we regularly experience may not always yield a favourable outcome, and our own resolve may be put to the test. Our reaction and approach to a resolution will be the true measure of whether or not we are becoming the better man.

Once again Brethren, I leave you with an excerpt from Most Worshipful Brother Norman E. Byrne's report in the Grand Lodge 1995 Proceedings. As a Past Grand Master and Chairman of the Discipline Committee he "Surely charity, toleration, a little common sense and a big helping of brotherly love would produce a much better result for all concerned. Your committee knows it is easy to say, but the exercise of the aforementioned Masonic virtues will produce much better results for an aggrieved brother, the lodge and even Grand Lodge, than the laying of Masonic charges in the heat of passion for a 'personal' affront or wrongdoing. The test may well be 'has this brother clearly and unequivocally offended Freemasonry generally? - or is it just me?'. A serious question, which deserves a serious answer."

Few items for your information.

#### **Grand View**

I am pleased to announce that in just two months Grand View has managed to sort though hundreds and hundreds and hundreds of data tables to import the correct pieces of data into our new Grand View system built by Masons for Masons. Thank you to the many Secretaries that assisted with identifying and reporting inconsistencies to allow our staff and Grand View to work through the tedious task of sorting through and finding the correct pieces of data. We still have some items we are working on, but our staff and lodges are well on our way to having a system that will benefit everyone and effectively and efficiently support our membership. Our Grand Lodge website has transformed into a public facing site which does not contain any personal, private or confidential information. All member details are now safely stored in our Grand View system which is only available to members. We continue to make good progress with setting up the necessary payment processing functionality that will allow us to open the store to members and open the door for functionality that can allow lodges to collect dues payments and sell tickets without having to set up and pay for their own merchant account. We have also made good progress on updating the Resources primarily under Master Mason, and we will continue to bring in the relevant and current missing resources as we sort through well over a thousand files that we were required to store in bulk outside our prior system. Many lodges are already taking advantage of built in document management and dues tracking. Entering lodge elections takes significantly less effort and applies the correct security and No more contacting access automatically. Grand Lodge to manually change administrator access every time a lodge officer changes. All changes, including for member records, take effect immediately. No more waiting for 24 hours. All that may be needed to see a change is a quick click of the refresh button. I hope you are already enjoying Grand View, and I know you

will enjoy Grand View even more as we roll out the functionality lodges and members have been looking for.

LATE ADDITION: POSTAL STRIKE

The postal strike is impacting many of us personally and professionally. Here are four areas that impact us in Masonry.

Postal Strike – Business that cannot be performed Section 269 of the Constitution confirms regular meetings can be held during an interruption of postal services, however no business shall be transacted if a summons is not delivered to all members including:

- •Vote to surrender warrant 179 (b) (ii) and 179 (c) (iii)
- •Honorary membership 187 (a)
- Demit with dues owing 194
- •Restoration 197, 198 and 203 •Remit dues 200 (b) and 200 (c)
- Remove officers 231
- •Elect vacant office 234 (b)
- Elect if Master-elect not confirmed 253
- •Elect if Examining Board not favorable for Masterelect - 255
- •Hold emergent meeting 272
- •Amend by-laws 305 (b) and 305 (d)
- Applications 319 and 362
- •Balloting 323 (a) and 323 (b)

Above business is permitted if hand deliver or courier summonses to members that do not receive the summons by email. All members must receive the summons.

#### Sending Lodge Summons Electronically to Grand Lodge

Per the Grand Lodge Policy dated March 23, 2023 - Lodges are permitted to send each summons electronically to the Grand Lodge Office in accordance with the following:

- ·Summons must be a single attachment emailed to summons@grandlodge.on.ca
- Attachment must be in PDF format or Microsoft **Word format only**
- •File size must NOT exceed 1 MB (one Megabyte)
- Filename must be Lodge number, 'summons', year, dash, month (no spaces)
- (e.g. "123summons2023-01.pdf" for the January 2023 summons of Lodge No. 123)
- ·If a revised summons, filename shall end in v2 (e.g. "123summons2023-01v2.pdf")

- •If an emergent meeting, filename shall end in e (e.g. "123summons2023-01e.pdf")
- ·Content shall be identical to that sent to all members

#### **eTransfer Lodge Dues**

Lodge dues are payable in advance (see Section 199 of the Constitution).

Lodges may offer the option of allowing members to pay lodge dues via etransfer, however payments must be appropriately recorded in the books of the Secretary and Treasurer. Please note that lodges offering an etransfer option must also accept the usual methods of payment including but not limited to cash and cheque.

If paying by the usual methods of cash or cheque, the Secretary collects all moneys and pays them to the Treasurer.

Recommended process for accepting etransfer payments for lodge dues:

- •Secretary sets up an email address for members to send etransfers to.
- ·Secretary, with assistance from the Treasurer, sets up etransfer auto-deposit into the lodge bank account
- •Secretary forwards each etransfer notice to Treasurer.
- Members should be instructed to include their name in the etransfer note.

In all cases, each payment must be recorded separately and individually in the Secretary's record book and in the Treasurer's record book.



Arkona Lodge No. 307 was instituted in 1874. On the night of its first meeting, the lodge was opened in the first degree at 8:05 pm with W. Bro. John Dallas presiding. W. Bro. Dallas read the dispensation from Grand Lodge and was elected Worshipful Master. The Lodge was dedicated by R. W. Bro. T. McNate, DDGM on October 14,1874.

Arkona Lodge has had several homes. The present Lodge building was purchased on September 4, 1919. Arkona Lodge was not the first Lodge to have electric power, but it was one of the first customers to be supplied by the Ausable Dam site of the Rock Glen Power Company.

Some of the Lodge minutes from the late 1880's and early 1990's include the following:

Dec. 27, 1876 - no attendance, heavy snow, secretary locked doors and went home.

Dec. 14, 1899 - new duties of the janitor would

Dec. 14, 1899 - new duties of the janitor would include lodge to be dusted and swept the day before meeting, lamps to be filled and cleaned, spittoons to be kept clean and polished and stove

to be lit one hour before lodge.

June 16, 1910 - received a letter from Grand Lodge requesting that the next regular meeting be a Memorial to M.W. Bro. King Edward VII Grand Master 1875-1901 and that the altar be draped for three months as an expression of respect.

Feb 16, 1910 - hydro bill was \$5.00 for the year.

#### Some recent highlights from the lodge:

- A night to remember for many Sarnia District Masons was Arkona Lodge's outdoor meetings at Arkona Fairways in the 2010s. These special nights each year in October brought visitors from across the District and far beyond to attend lodge outdoors under the stars. 
### Masonic Rsearch: A Success Story

This summer, the Grand Lodge Library welcomed a particularly engaging visitor: Dr. Robert Fraser of the University of Toronto, managing editor of the Dictionary of Canadian Biography.

His purpose was to verify details about the life of Richard Beasley—a Freemason who settled in Upper Canada in the late 1700s and among the earliest pioneers of the Hamilton area. Beasley established his homestead at the head of the lake, on the site where Dundurn Castle now stands. Shortly after arriving, he became a charter member of The Barton Lodge (now No. 6 G.R.C.—and, of course, this was prior to the formation of the Grand Lodge of Canada).

John Ross Robertson's History of Freemasonry in Canada duly lists Beasley as one of The Barton Lodge's founders. In that work, Robertson references a letter from Beasley



to the Provincial Grand Master, William Jarvis, concerning "Masonic and personal matters," and reproduces a brief excerpt—curiously, one that does not touch on the Masonic content.

But was Robertson's quotation accurate? And what else did the letter contain—material, perhaps, of interest to Beasley's biographer? The search began for the original.

William Jarvis, Provincial Secretary and Registrar under Lieutenant Governor John Graves Simcoe, was a prominent figure in early Canadian government. Given his stature, it seemed reasonable to hope that a document addressed to him might survive. Yet searches in the obvious repositories—national, provincial, and City of Toronto archives—produced nothing. We also learned of a 1960s thesis concerning Bro. Beasley; its author was located but could provide no information on the letter's whereabouts.

Robertson's reference suggested he had seen the letter in 1900, when his History was published. The investigation therefore shifted to the fate of his papers. V.W. Bro. Marshall Kern advised that a portion of M.W. Bro. Robertson's source materials had been donated to the Toronto Reference Library, later transferred to the Masonic Temple at 888 Yonge Street, and, upon that building's closure, moved to the Grand Lodge Library.

Which brought the search, at last, to our door.

We do indeed hold a John Ross Robertson collection. Among its contents is a substantial ledger containing original manuscripts used in compiling his history—and within that ledger lies the very letter in question. The search concluded in success.

The complete letter appears below. See if you can identify what made it so compelling.



A Masonic Incident

Reprinted from **The Michigan Freemason** Vol. VII, No. III (January 1876), pp. 67-70.

My case is not without precedent. Others have buried alive before me, and, by good fortune, exhibited evidences of consciousness in time to secure a rescue. But I presume that I am the first Freemason ever subjected to this discipline. Will the readers of the Keystone listen to my story?

My health from my boyhood had been feeble. I am not scholar enough to describe or even name my peculiar ailment; but I was always hard to wake from sleep, sometimes had fainting fits, suffered much from swimming in the head, and the like. I became a Mason at the age of twenty-four, and found the association, in all respects, pleasing and useful. The Lodge worked carefully and well. No erring Brother stood a chance of being overlooked until his sin grew chronic within him. We had no disreputable Brethren among us. Yet we were social, and had high jinks whenever the Craft was "called from labor to refreshment." We sung the Masonic songs well and freely. Twice a year a bounteous banquet was spread, which, with the attendant joyabilities, was always anticipated by the members with rare relish. In brief ours was more than an ordinary Lodge.

One afternoon I had gone into the woods to select a piece of timber for a particular work—I am a wagon-maker by trade—and finding a suitable tree, I began to cut it down. While doing so a large snake came suddenly out from a hollow place near the ground and passed directly between my feet. I always had an antipathy to snakes, and the suddenness of its appearance threw me into a fit. I fell backwards to the ground, as if dead. The wood-chopper who was with me took me on his shoulder—I am a very light weight—and carried me directly to my boarding house, summoning a physician, whose office we passed, to wait upon me.

All efforts to resuscitate me, however, failed. Applications of all sorts, even the most pungent vivisections, the hot bath, electricity itself, was tried upon me; but my appearance was that of a dead man, and, at last, the medical practitioner declared that "life was extinct."

It was about this time that my dormant senses returned to me; at least, I cannot remember with distinctness anything which occurred before I heard—and, oh! how distinctly the voice falls upon my ears—"He is dead." Some one remarking upon my florid appearance and the warmth of my flesh, I heard the doctor explain, with quite a display of erudition, that "such phenomena were not rare in persons of my peculiar temperament; but that these were not appearances of vitality." He advised, however, that no steps should be taken for my burial until the plainest evidences of death were apparent. Then I heard the doctor leave the room, and the conversation of the two or three persons around me, expressing surprise (no one gave utterance to grief) at my sudden death. Then my body was laid out in the usual manner, but with, what I thought, to be, unnecessary coarseness

and indelicacy, and I was left nude and alone, in a dark room.

All this time, I confess, my feelings were rather of a ludicrous nature, mingled with some indignation, than of fear. I felt so confident of reviving in a few hours that the thought of how droll would be the scene at my unexpected resuscitation was uppermost in my mind. I had that indistinct perception of passing objects common to a state of coma, yet could concentrate my ideas upon a single point with considerable force. The lines "Solomon strikes the funeral chime," rang in my

mind. The job on which I had been engaged occupied much of my thoughts, and I computed over and over the measurements of the timber upon which I was reflecting at the moment of my attack.

The night passed rapidly enough, and daylight seemed as plain to me, through my closed lids, as on any other occasion. Then I became a silent witness to a scene never to be eradicated from my memory.

A delegation from the Lodge came to the room, and, for a considerable period, stood around me in consultation. Their words were tender and sympathetic. They had telegraphed, as I learned,

to my widowed mother, and the funeral would proceed as soon as she arrived. At a called meeting, the evening before, they had assumed all the expenses of my interment, together with those for a monument, which they had already ordered. They had adopted eulogistic resolutions in my honor. They had, in brief, taken prompt steps to assure my mother, my friends, and the entire community, of their respect for my memory.

Now I was laid in the coffin, and my body removed to the Masonic Hall, where a guard of Brethren was detailed to stand watch over me through the second night. It must have been one or two o'clock in the morning that a final consultation was held over my body to decide the solemn question of death. The ruddy appearance of my skin and the high temperature of my flesh, before adverted to, had excited much surprise, and no less than four physicians, together with the coroner, several experienced undertakers, and others, stood around me to settle the question.

And now, for the first time, I began to feel some alarm. The reader will, of course, understand that my mind was not in a logical condition. In truth, it must have been in a very feeble state of

action, so much so, that I had not previously contemplated the possibility of premature burial, nor realized the horrible condition in which I was placed. But as test after test failed, when acrid substances put under my eyelids, and sharp instruments penetrating my nerves, and great charges of galvanism, throwing my N muscles into spasms, failed to elicit a single evidence of real life; when I heard the coroner and the undertakers one and all declare me "dead as Julius Caesar"-in fact, when the last of the experts ceased his experiments, and retired from the Lodge room, a horrible fear began to come over me, to which language is inadequate to give expression, a fear which continued but with ever

increasing intentness until the end of the chapter. My life was saved by the fortuitous circumstance of a railroad accident, which prevented the arrival of my mother. This necessitated placing my body in a vault, that upon her coming she might once more look upon my face, before my remains were finally interred. In all other respects the funeral services proceeded as though I was to be placed in mother earth. The beautiful Masonic services were performed in opening a Funeral Lodge, my coffin lying near the altar in the center. The appointment of a Marshal, his orderly arrangements for a procession, the beautiful prayer of the Chaplain,



the selection of pall-bearers—how well I understood these details! Every word of the Master's eulogy fell upon my ears, and I followed him, mentally, line by line, as he recited that funeral poem, commencing "Dead, but where now," &c.

It would be spinning out this subject unnecessarily to describe the procession, and the proceedings in the church and receiving vault. Suffice that all things were done with exceeding gravity and decorum. My body was taken first to the Methodist Church, where a funeral discourse was given, in which my character was tenderly reviewed; then to the graveyard, where I was deposited, as I have said, in one of the vaults, fortunately open to the air. At the suggestion of one of those who had retained a lurking skepticism as to the fact of my death, the lid of the coffin, immediately above my face, was slightly loosened, to which circumstance I probably owe my life.

The horrors of that night—why should I relate? Consciousness fully restored. One by one of my muscles yielded to my agonized will, and I moved my feet and hands, opened my eyelids; I screamed aloud. More than once I must have fainted, and recovered. And when my mother, tottering into that horrible receptacle of the dead, came to look upon my face, it was bathed with a clammy perspiration, the eyes were open, an expression of horror overspread it which was too much for her affectionate heart. She fell upon my coffin senseless, and was long in being revived.

I need not say that no time was lost in releasing me from my confined situation and restoring me, by the aid of hot baths and tenderest care, to strength. A handsome sum of money was made up, by which I was enabled to travel for several months in the company of my mother, and until the horrible impressions of that premature interment faded from my mind. — The Keystone.



# FROM THE GRAND CONTROL ARCHIVES

This month's submission shows three jewels from the Grand Archives collection. They are; the Royal Masonic Benevolent Institution (RMBI) 1935 jewel, the Royal Masonic School for Boys 1923 jewel, and the Royal Masonic School for Girls 1922 jewel.

These impressive jewels, from outside our jurisdiction, demonstrate the international interest and support for three important institutions that were established and administered by Masons. Originally, these charities were created exclusively for the care of Masons and their families. Over time however, the services they offered were eventually extended to the general public.

It is interesting to note that the organizations highlighted on the jewels were created to support two key times in life; youth and old age. Then, as now, these were recognized as vulnerable ages in our society.

In this article, I'll examine the 1935 Royal Masonic Benevolent Institution jewel. The Royal Masonic Institution for Girls jewel and the Royal Masonic Institution for Boys jewel will be examined more fully in a later issue of this publication.

The Royal Masonic Benevolent Institution (RMBI) is one of the oldest Masonic charities, with origins in early 1840s England. The RMBI demonstrates the long-standing traditions of fraternity, moral instruction, and philanthropy, and established support for its members and their families.


This institution was officially founded in 1842 as the Royal Masonic Benevolent Annuity Fund for Aged Freemasons and their Widows. Its early mission was simple: to provide financial support for elderly Masons, widows, and orphans in need. This focus reflected the Masonic commitment to relief, charity, and brotherly love, and ensured that no Brother or his dependents would suffer neglect in their later years.

The Royal Masonic Benevolent Institution jewel in our collection is missing its red ribbon and upper plate. Based on 1935 jewels in other Masonic collections, the missing plate would be imprinted with "Steward".

By the mid-19th century, the RMBI began to evolve beyond annuities. Recognizing the growing need for dedicated residential care, the RMBI opened its first supported care home Home in Croydon, England in 1850 and was named the "Asylum for Worthy, Aged and Decayed Masons". Over time, additional Homes were established across the United Kingdom. Today, 17 RMBI care homes operate across England and Wales offering high-quality residential and dementia care.

The 1935 jewel expresses how the RMBI commemorated milestones and honoured support from Lodges and individuals. The Latin motto displayed, "Virtute et Labore", meaning "Virtue and Labour" embodies both Masonic principles and the values of the RMBI's charitable mission.


